You have been asked to be notified of upcoming training dates for the Onsite Wastewater Practitioner Training Program. Successful completion of this training is required by Alberta Municipal Affairs for those people wishing to obtain a Certificate of Competency (formerly a PSDS Ticket) to work in the onsite wastewater industry. This program is also recognized in British Columbia under the Trade, Investment and Labour Mobility Agreement (TILMA) and the New West Partnership, in Saskatchewan under the New West Partnership and in Manitoba under the agreement on Internal Trade.

The Onsite Wastewater Practitioner Training Program is currently an eight day in-class course and a one-day field training class.

- You must complete all prerequisite training and eight days of classroom training with a passing grade of 75% on all training components in order to receive certification.
- You must also complete a mandatory Site and Soil Evaluation Field Training Day. This is the ninth day of training and will be scheduled throughout the installation season. Fees for the Site and Soil Evaluation Field Training Day are included in the tuition fees.

The confirmed training dates for the next session are:

Days 5-8: January 30 and 31, February 1 and 2, 2024
